**RE-ORGANIZING THE MUNICIPAL HEALTH BOARD OF THE
MUNICIPALITY OF STO. NIÑO, CAGAYAN**

WHEREAS, Section 102 (a) (3) of the Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandates local government units to establish a local health board in every municipality;

WHEREAS, in pursuit of these mandates, there is a need to create a Local Health Board of the Municipality of Sto. Niño;

NOW, THEREFORE, I, ATTY. VICENTE G. PAGURAYAN, Municipal Mayor of the Municipality of Sto. Niño, by virtue of the power vested in me by law, do hereby order:

SECTION I. ORGANIZATION AND COMPOSITION: The Municipal Health Board of Sto. Niño, Cagayan, hereinafter referred to as the Board, is hereby organized and shall be composed of the following:

SECTION II. FUNCTIONS: Pursuant to the provisions of the Local Government Code of 1991, the Board shall exercise the following functions:

1. To propose to the Sangguniang Bayan, in accordance with the standards and criteria set by the Department of Health, the annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality;
2. To serve as an advisory committee to the Sangguniang Bayan for, and in application of local appropriations for public health purposes;
3. Consistent with the technical and administrative standards of the Department of Health, create committees, which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions:

SECTION III. MEETINGS: The Board shall meet at least once a month or as often as may be necessary.

SECTION IV. COMPENSATION AND REMUNERATION. The Chairman, Vice-Chairman and members of the Board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary travelling expenses and allowances chargeable against the funds of the Board, subject to existing accounting and auditing rules and regulations.

SECTION V. DIRECT NATIONAL SUPERVISION AND CONTROL BY THE SECRETARY OF HEALTH. As provided in Section 105 of Republic Act NO. 7160, in cases of epidemics, pestilence and other widespread public health dangers, the Secretary of Health may, upon the direction of the President and in consultation with the Local Government Unit concerned, temporarily assume direct supervision and control over health operations in this Local Government Unit, i.e., having supervision over the Board, for the duration of the emergency, but in no case exceeding a cumulative period of six (6) months. With the concurrence of the Local Government Unit through this Board, the period of such direct national control and supervision may be further extended.

SECTION VII. EFFECTIVITY: This Executive Order shall take effect immediately.
