AN ORDER RE-ORGANIZING THE RETOOLED COMMUNITY SUPPORT PROGRAM (RCSP) MUNICIPAL CORE TEAM AND PROVIDING FUNCTIONS THEREOF

WHEREAS, Section 5, Article II of the 1987 Constitutions provides, among others, that the maintenance of peace and order, the protection of life, liberty and property and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Executive Order No. 70 was issued institutionalizing the Whole of the Nation Approach in attaining inclusive and sustainable peace, creating a National Task Force to End Local Communist Armed Conflict and directing the adoption of a National Peace Framework;

WHEREAS, the Whole-Of-Nation Approach addresses the root causes of insurgencies, internal disturbances and tensions and other armed conflicts and threats by prioritizing and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and ensuring active participation of all sectors of the society in the pursuit of the country's peace agenda;

WHEREAS, the Retooled Community Support Program (RCSP) was formulated in order to strengthen the Community Support Program of the military;

WHEREAS, Memorandum Circular No. 2019-169 dated 11 October 2019 issued by the Department of Interior and Local Government provides for the implementation of the Retooled Community Support Program through the concerned local chief executives;

WHEREAS, DILG Memorandum Circular 2019-169 requires the organization of the Retooled Community Support Program (RCSP) in the municipal level with the following composition which shall serve as the unit that directly provides all the necessary tactical, technical, logistical and administrative assistance to the Local Chief Executive (LCE) in the performance of its function as the RCSP Head, to wit;
