**MUNICIPAL ORDINANCE NO. 02**  
*Series 2023*

**“AN ORDINANCE AMENDING SECTION 1, SECTION 2 AND SECTION 3 OF MUNICIPAL ORDINANCE NO. 08-2019 ENTITLED; ORDINANCE SETTING THE SECOND WEEK OF AUGUST FOR THE CELEBRATION OF LINGGO NG KABATAAN IN THE MUNICIPALITY OF STO. NIÑO, CAGAYAN, PROVIDING FUNDS THEREOF AND FOR OTHER PURPOSES.”**

Be it Ordained by the Sagguniang Bayan in session duly assembled that;

**SECTION 1. AMENDMENTS.** Section 1, Section 2 and Section 3 of the existing ordinance is hereby amended as follows;

*SECTION 1. TITLE. This ordinance shall be known “ORDINANCE SETTING THE CELEBRATION OF LINGGO NG KABATAAN IN THE BARANGAY AND MUNICIPALITY OF STO. NIÑO, CAGAYAN IN AUGUST PROVIDING FUNDS THEREOF AND FOR OTHER PURPOSES”.*

*SECTION 2. POLICY. It shall be the policy of the Municipal Government of Sto. Niño, that Sangguniang Kabataan in every Barangay and the SK Federation in the municipality shall be mandated to celebrate annually the Linggo ng Kabataan preferably in any week of August with the conduct of any of the activities, that are geared towards caring, development, empowerment, engagement, advancement and welfare of the youth which includes the following: Tree-planting, Clean-up Drive, Symposium, Continuous Training, Sport League, Youth Camp, Recognition for Outstanding Youth in the Barangay, Education, Arts and Cultural Activities, Showcasing of Talents and the conduct of “AKO, IKAW” activity where individuals ages 15 to 17 can act as barangay official in barangay level and act as municipal official in municipal level. The activities on the Celebration of Linggo ng Kabataan shall be included in the ABYIP and CBYDP of the Sangguniang Kabataan at the Barangay level and Sto. Nino, Cagayan Youth Development Plan and the AIP/APP/WFP of the Local Youth Development Office.*

*SECTION 3. FUNDING. The funding of the conduct of activities for the celebration of the Linggo ng Kabataan at the barangay level shall be charged from the SK Funds and the municipal government shall allocate the amount of Two Hundred Thousand Pesos (P200,000.00) from the Annual Budget of different concerned Departments of the LGU for the Linggo ng Kabataan celebration yearly. This shall be augmented by the registration fee of the Sangguniang Kabataan at the barangay level who shall be participating the activities of the celebration of the Linggo ng Kabataan at the municipal level, if necessary.*

**SECTION 2. SEPARABILITY CLAUSE.** - If any provision of this Ordinance is declared unconstitutional, the same shall not affect the validity and effectivity of the other provision hereof.


**SECTION 3. REPEALING CLAUSE** - All laws, decrees, executive orders, rules and regulations and other issuances or parts thereof, which are inconsistent with this Ordinance, are hereby repealed, amended, or modified.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect upon its approval and upon compliance with the mandatory posting requirements prescribed under R.A. 7160.
